Foreword



An annual report is a snapshot of an organization. This edition again gives an impression of the broad range of activities in which the Royal Tropical Institute was involved in 2006, and the current position of the organization. Many projects run for several years, so the report does not aim to give a comprehensive picture. It does, however, both look back over the past year and forward to the future.

A multi-facetted, medium-sized organization, in 2006 the Institute again actively worked to support poverty reduction, the conservation of global cultural heritage and the achievement of the Millennium Development Goals. Many individuals, donors and organizations in both the public and private sectors, and many others, benefited from our activities.


As professionals we are proud of our results in 2006. The exhibitions in our museum drew large numbers of visitors. We retained our position as a leader in scientific research and the diagnostics of infectious tropical diseases. Interest in intercultural management and communication grew, and we innovated in our information services for developing countries.

The Institute carried out major projects in sustainable economic development and health care on behalf of public authorities, national and international development organizations and other institutions. Our musical and dance performances were well received by both the public and the press, and our publications sold well. The links between all these activities were also tightened, increasing professionalization in the Institute, building our profile and guaranteeing continuity in our activities.

The financial results show that it is not easy to cover one's costs in all this. The Institute strives to operate in the most efficient and effective way possible on a not-for-profit basis. But good organization costs money, even if only to comply with the legislation that guarantees the welfare of our staff. The public and private 'market' in which KIT operates is still volatile, and there is often no level playing field. The implications of this for our operations remain a constant focus of attention, and sometimes give cause for genuine concern. The Institute proved in 2006 that it stands for solidity and continuity, but the setting in which it operates means it must always be on its guard.

We have been pleased to note growing support for international efforts to achieve social and sustainable economic development and good governance. It is important that we keep the issue of good governance in our own sector in mind as well. We have seen the concentration and coordination of cooperation across borders, but our infrastructure to support and to guarantee effective development cooperation is quite fragmented. External conditions are not always that favourable. Some (re)structuring and rethinking are required. This is a challenge for all actors: private initiative and charity cannot do this alone but need leadership, support and guidance from politicians, policymakers and all who support our efforts.

The Institute at a glance

The Royal Tropical Institute (KIT) is an independent centre of knowledge and expertise in the field of international and intercultural cooperation. The aims of KIT are to contribute to sustainable development, poverty alleviation, and cultural preservation and exchange. Within the Netherlands, it seeks to promote interest in and support for these goals.

KIT conducts research, organizes training activities, and provides consultancy and information services. KIT develops practical expertise in policy development and implementation. KIT also manages cultural heritage, organizes exhibitions and other cultural events, hosts meetings and provides a forum for debate. A key objective underlying KIT's work is to enhance and exchange knowledge of and understanding for different cultures.

KIT is a not-for-profit organization that works for both the public and the private sector in collaboration with partners in the Netherlands and abroad.¹

Basic facts

KIT was founded in 1910 as the Colonial Institute to study the tropics and to promote trade and industry in the (at that time) colonial territories. It was founded on the initiative of a number of large companies, with government support, making it an early example of a public-private partnership.

The Institute's origins are reflected in its statutory form. It is an association with private and corporate members. The association has a Council of Members, a Board of Directors and a one-person Executive Board. It also has an Advisory Board consisting of leading international experts.

KIT has a turnover of approximately \leq 40 million and employs around 400 people, half of whom work on international projects. Production agreements with the government determine around 45% of its activities.

Since 1926, KIT has been housed in a historic building specially designed by the architects J.J. van Nieukerken and sons. The building is richly adorned with decorative features and symbols referring to different cultures of the world and the colonial history of the Netherlands.

HRH Princess Máxima is the Institute's protectress. HRH Prince Bernhard and HRH Prince Claus both held the position of honorary chairman in the past.

Fields of operation

KIT provides products and services in three areas:

Development and Health

KIT's work in the field of economic and social development, health improvement and tropical diseases is the responsibility of two departments:

- KIT DEVELOPMENT POLICY & PRACTICE, which provides research, advice and capacity building on international health care, economic, social and institutional development, and gender issues;
- KIT BIOMEDICAL RESEARCH, which conducts health research, advises on capacity building for health research, and develops diagnostic tests for tropical diseases.

Culture

Activities involving the cultural aspects of development and cultural exchange are the core business of:

- TROPENMUSEUM: the oldest and most diverse ethnographic museum in the Netherlands, which also supports museum capacity building in developing countries. A special branch of the museum is the Tropenmuseum Junior, which is specifically aimed at children.
- TROPENTHEATER: a leading international venue for non-Western culture in the form of music, dance, theatre and film, as well as a platform for lectures and debate.

Information and Communication

The following departments are involved in the sharing and exchange of knowledge, including intercultural communication, and the provision of information services, publications and training:

- KIT INTERCULTURAL MANAGEMENT & COMMUNICATION provides management consultancy, training and coaching services.
- KIT INFORMATION & LIBRARY SERVICES manages one of Europe's largest collections of works on international and development cooperation, and also provides information services to developing countries.
- KIT PUBLISHERS² produces publications on art and culture, travel, intercultural communication and international cooperation.

The Institute in 2006

As a modern knowledge institution working for sustainable development, international health care and culture, the Royal Tropical Institute (KIT) collaborates with universities, research institutes and development organizations throughout the world.

The new corporate identity, introduced in 2006, clearly expresses this identity. The new logo – a stylized tree – strikingly depicts KIT's ambitions and goals. It represents international cooperation and knowledge-sharing as the Institute's core activities, aimed at improving people's choices and opportunities. The new logo was unveiled on 28 September in the presence of our protectress HRH Princess Máxima.

Poverty reduction, social and economic development and the preservation of cultural diversity throughout the world continue to be key priorities for KIT. They are increasingly intertwined with issues such as peace, security, migration and globalization, all of which affect development activities and other forms of international cooperation and therefore impact on KIT's work. The core of our mission therefore remains as topical as ever: to encourage mutual understanding and a fundamental respect for people from other cultures.

Global development presents the Institute with a continuous challenge in terms of research, expertise development, education, consultancy and information provision. We meet that challenge by engaging in activities aimed at ensuring that developing countries participate in and are integrated into the global economy, by providing training in intercultural communication, and by training civilian and military doctors for work in the tropics. Our response to that challenge is also reflected in new diagnostic methods we are developing for infectious diseases, and in our studies and publications, exhibitions, concerts and theatre presentations.

Effect and capacity

The Millennium Development Goals – the international agreements to halve global poverty, reduce hunger and infectious diseases, to improve health, education and care for the environment – currently define the development agenda and shape KIT's agenda too. Another item on that agenda is the effectiveness and efficiency of development cooperation itself. The Institute is involved in a number of activities to determine the impact of development efforts. In 2006 an independent commission set up at the initiative of KIT and development organizations ICCO and SNV published a report on this issue. The commission, chaired by former minister of the interior and Kingdom Relations Hans Dijkstal, analyzed the playing field on which the development sector, government and society interact. It expressed reservations about the measurability of results, accountability, and trends in public support and communication. The organizations involved have responded to the commission's recommendations by initiating a series of follow-up activities.

Efforts to build up developing countries' own capacity for development continue, and go hand in hand with a growing self-confidence and entrepreneurship. Capacity development and participation are important in practically all of the Institute's fields of operation and in the way its staff think and act. In this context, the Ministry of Foreign Affairs entrusted KIT with the implementation of a new support programme for its embassies in developing countries. The Support Programme for Institutional and Capacity Development (SPICAD) aims to remove institutional bottlenecks to make Dutch development efforts more effective. With financial support from the Ministry, KIT also initiated the "People, Markets & Values" programme, which aims to increase the role of small farmers and agricultural and horticultural

producers in developing countries in production chains. Regarding private sector development, KIT explored the possibilities for helping to start up companies in developing countries by taking an active part in management and through direct funding.

Dutch and international business are currently more active in developing countries. Companies – including small and medium-sized enterprises – contribute knowledge and experience and encourage local trade and industry through investment. Increasingly, KIT acts as a broker, building bridges with local organizations like farming cooperatives and NGOs. One inspiring example of this is the development of sustainable international production chains for local products like fish, fruit and spices. The Institute was active in this area in India, Ghana, Mali, the Dominican Republic and among other places.

Innovation and growth

The main ambition outlined in KIT's strategic document "KIT 2005-2010 – Future Directions in Development" is to be an innovative and effective knowledge institute with products and services that can be marketed nationally and internationally. Developments in 2006 showed that the Institute's pursuit of that ambition has had its setbacks. Serious financial problems at KIT Publishers, for example, made a radical reorganization inevitable. Eventually, KIT Publishers managed to achieve an acceptable financial result.

KIT operates in the space where the public and private sectors meet, and must offer value in terms of substance and quality and be cost effective in both markets at the same time. In 2006 the Institute was regularly confronted with a less—than-level playing field. Public authorities and other clients rightly require that KIT comply with statutory requirements, which has an impact on the rates we charge for services. In practice, however, these clients are not always consistent in applying the same criteria to service providers from other countries.

Growth – another of our strategic ambitions – is crucial for the Institute, but we are not growing as rapidly as we had hoped, or as we need to. A number of activities came to an end in 2006, including the implementation of the sustainable development agreements between the Netherlands and Costa Rica, Bhutan and Benin. That meant a considerable fall in turnover, which could only be partially compensated for by other developments and professionalization in other areas.


Continuity, innovation and growth are essential if KIT is to operate on a financially sound basis. It is a challenge calling for daring, stamina and entrepreneurial spirit. But this is no simple task. The 2006 financial year closed with a larger deficit than budgeted, albeit smaller than in 2005. This prompted an investigation of the measures required to ensure that we can operate at least within budget in the future and, preferably, cost-effectively. These measures include increasing our revenue by developing for-profit activities, without losing sight of the Institute's ideals. Other elements of this process include streamlining administration and management and further cutting of overheads.

Building a future

Against this background, a fundamental discussion was initiated in 2006 on the Institute's work, focus, direction and structure. Increasingly, joint activities are being initiated between departments to promote synergy both within and outside the organization. The management structure and the role of the management team in decision-making were important talking points. One major innovation in this respect was the setting up of Holding KIT BV, a full subsidiary of the Royal Tropical Institute Association. In addition to the NH Tropenhotel and KIT Publishers, participating interests in new businesses in developing countries can also be pursued via the new holding company.

In a continually changing world, strategic flexibility is vital. The debates on direction, focus and structure do not stand alone. They have been prompted by developments – and sometimes the lack of them – in the environment in which we operate. This relates not only to our partners in the field, but also to our own drive to grow and develop further.

In this respect, KIT's plans to extend its premises are inspiring and forward-looking. They include a new, modern and more public-friendly entrance to the museum, a larger multifunctional theatre, a new hotel and extra office facilities.



For the Royal Tropical Institute (KIT), research and advisory services are closely related. Research helps people finding solutions to problems such as poor governance, diseases, knowledge deficits or cultural poverty. Appropriate research generates knowledge and insights, which can be translated into clear and, above all, practical approaches and effective support for local initiatives. This is what KIT does well and with genuine passion, in a wide range of areas and in many parts of the world. We do so with inspiration, knowledge and know-how, experience and conviction, and with a focus on people taking control of their own development. This section explores the multi-faceted world of research and advisory services at KIT.

Culture

Culture brings different worlds together. KIT presents a world of cultures in the Netherlands and abroad, but culture is much more. It is also about capacity development elsewhere. And it is about managing our collection and cataloguing – and thus protecting – works of art, science and material culture. The world of culture is as multi-faceted as culture itself.

More than a theatre

With its unique programme, the Tropentheater occupies a special position in the performing arts sector. Take, for example, the expert meetings that the theatre organizes for professionals and its involvement in capacity building in the performing arts in developing countries. During the World Musical Theatre Festival, for example, an expert meeting was organized for marketeers. The Tropentheater commissioned Catharsis Productions to stage a meeting on age diversity and audience development. During the Amsterdam Roots Festival, the Tropentheater organized a meeting on world music and the creative industry. A meeting on building in non-Western countries was organized with Arcam, the Amsterdam Centre for Architecture. In September, monthly network meetings for world music, known as World Blend Café, were launched. A meeting entitled Crime Passionnel/Crime Culturel, the latest in the series on honour killings, with UN rapporteur Yakin Ertürk as guest of honour, also attracted a lot of attention.

Capacity building in Suriname

The Tropentheater's main focus of capacity building efforts abroad was on Suriname. Missions to Suriname resulted in promising contacts with representatives of the cultural sector. Questions from the sector were analyzed to prepare the ground for a local capacity building project. The Tropentheater hopes to support its colleagues in Suriname over the next few years in terms of networking, organization, international contacts, broadening their frame of reference and coaching. More specifically, interviews were held in November with a group of 12 young candidate directors and choreographers, leading to the selection of three talented theatre-makers. Cooperation will continue in 2007 with visits to a number of international festivals and the organization of meetings and a peer-to-peer learning programme. The project should result in a number of independent productions, which the Tropentheater will also present in the Netherlands.

Artworks returned to Suriname

On 29 June 2006, the Tropenmuseum donated 45 works of art to the Surinaams Museum in Paramaribo. The works, which date from before Surinamese independence, come from the collection of the Cultural



Cooperation Foundation, which was set up in 1948 to promote cultural contacts between the Netherlands, Indonesia, Suriname and the Dutch Antilles. The return of the works was the culmination of many years of cooperation between the Tropenmuseum and the Surinaams Museum, which also resulted in the renovation of a repository and a hall for temporary exhibitions.

Tropenmuseum showcases Indian migrant culture in Bidesia project

Around 1900, many Indians were recruited as indentured labourers for overseas plantations in Suriname and elsewhere. The Hindustani Surinamese are the descendants of those labourers from India.

Strangers from India

Bidesia is the name of the traditional poetry and song of the present-day Indian states of Uttar Pradesh and Bihar. 'Bidesh' is the Bhojpuri word for 'foreigner' or 'stranger'. In the colonial era many indentured labourers were taken from the region to work on plantations in the Caribbean and Suriname. The Tropenmuseum is running a project researching and tracing the Hindustani oral tradition in Suriname and the Netherlands, linking it to its Indian form. As such, the project is also making a link between Sarnami - the language of Surinamese Hindustanis - Bhojpuri and other languages spoken in the country of their ancestors.



Bidesia – a Bhojpuri term for "foreigner" or "stranger" – is a joint project involving Suriname, the Netherlands and India which aims to document and highlight this migrant culture. One of the results of the projects has been the Kahe Gaile Bides - Bhojpuri Culture and the Diaspora exhibition, which opened in September in Allahabad in the Indian state of Uttar Pradesh. The exhibition shows why the Indians left and how they succeeded in preserving their original culture so far from home and for so many generations. The Bidesia project, led by Dr Badri Narayan Tiwari, is being implemented by three institutions: the GB Pant Social Science Institute in Allahabad, Anton de Kom University in Suriname, and the Tropenmuseum. Bidesia is financed by the institutions themselves, with the support of the HGIS Culture Fund, the Mondriaan Foundation and the Prince

Object Identity and Registration for security

Many museums are victims of theft and illicit trade. The digital registration of the unique characteristics of artworks can help to address these problems. The Tropenmuseum helps museums throughout the world to register their collections, using a software programme called Object Identity and Registration. This OIR, which also includes a training component, has been presented at the International Council of Museums. ICOM has also presented the programme at UNESCO, and reactions to date have been positive.

A cultural centre for Sintang, Indonesia

The Tropenmuseum is contributing to the development of a centre for regional history and cultural heritage in the Indonesian district of Sintang on Borneo. The centre will include archives, a library and exhibition space. KIT trained staff for the new centre. An earlier study on the written, material and photographic sources on the history of Sintang has been translated into Bahasa Indonesia.

Collection management

The Tropenmuseum and KIT Information & Library Services work closely together to assist partners in developing countries with the management of museum and documentary collections. In 2006 they worked with the Surinaams Museum and the Sintang Cultural Centre.

Good governance

Rights-based approaches to development start from the understanding that the purpose of development is the expansion of human freedoms.

Strengthening the development of responsive and effective local and national government institutions, and building the capacity of citizens to participate effectively and articulate their rights, are central to KIT's work on good governance.

Supporting rights

KIT works with governmental and non-governmental partners to integrate rights-based approaches into their development activities. In 2006, KIT trained the partners in the Eastern Africa Coalition on Economic Social and Cultural Affairs (EACOR) in Nairobi to use a rights-based approach in situational assessments. A Similar training was also given at the Dutch embassy in Bangladesh. Together with the Centre for Applied Legal Studies (CALS) in South Africa, KIT has developed a new course entitled Building Capacity for Rights: Democracy and Development in Africa, which will be offered for the first time in Johannesburg in 2007.

Documenting experience

Information is contained in books, but knowledge and experience are found in people. KIT documents and publishes people's practical experiences, so that others can benefit from them. One example is its documentation of experiences with decentralization and capacity building at local level, which can provide important input for national policy dialogues. In Benin, where decentralization started in 2003, it is still very much a learning process for mayors and councillors, civil society organizations, the private sector and the national government. A report on this process, entitled Les premiers pas des communes au Bénin: enseignements du processus de la décentralisation, was published by the Centre pour l'Environnement et le Développement en Afrique and KIT in April 2006. In the same month, Benin's new president Boni Yayi was inaugurated, raising hopes of better governance and a more just society.





Tuberculosis diagnosis and mutations in bacterial DNA

Previous research conducted with the KEMRI medical research institute in Kenya has helped build the evidence base for the use of fluorescence microscopy (FM) in diagnosing tuberculosis. The use of light emitting diodes in FM speeds up the diagnostic process and helps in patient detection. The results of an FM evaluation in Vietnam are to be published in The Lancet Infectious Diseases (in press; 2007).

Resistance to antibiotics in tuberculosis bacteria is caused by mutations in the bacterial DNA. KIT Biomedical Research has established that some mutations are accompanied by a mild form of stress that probably causes more mutations, bringing an increased risk of multiple resistance.

KIT is taking part in an international project launched in 2006 to determine how vaccination and treatment programmes are impacting on the tuberculosis epidemic. We also participate in international working groups established to improve the diagnostic process for tuberculosis.

Malaria and leprosy

KIT was involved in a range of clinical trials in 2006. Our NASBA test shows that malaria gametocytes remain in the blood after treatment and that patients can still transmit the disease. In 2006 a trial started in Rwanda to seek the best way of preventing malaria among HIV-positive pregnant women.

The harsh reality of HIV/AIDS

Russia faces one of the fastest-growing HIV/AIDS epidemics in the world. As the number of infected adults grows, so do the chances that the virus will be transmitted from pregnant mothers to their babies. In 2003 the Russian government asked the AIDS Foundation East-West to assist with a project to improve prevention and provide care and support for infected mothers and their children. KIT Development Policy & Practice evaluated this project in 2006 and drew up recommendations for improvements. At the request of the AFEW Knowledge Centre, KIT Information & Library Services assisted in making electronic sources accessible online.

Malaria extra risk to pregnant women with HIV

The combination of HIV and malaria is a major problem in Africa, and pregnant women and children are particularly vulnerable. Women infected with HIV have been found to be extra susceptible to malaria, and malaria increases the risk that they will transmit HIV to their unborn child. The INTERACT project is studying how safe the latest anti-malaria drugs and prevention programmes are for both HIV-positive and healthy women during pregnancy.

A test in Bangladesh to determine the effectiveness of rifampicin in preventing leprosy showed that it provided protection in 60% of cases. This is an important step forward in the effort to reduce the incidence of leprosy. KIT Biomedical Research organised an international workshop on leprosy prevention.







The report *From Access to Adherence: the Challenges of Antiretroviral Treatment,* published by the World Health Organization, the University of Amsterdam and KIT in 2006, exposes the harsh reality faced by people living with HIV/AIDS in Botswana, Tanzania and Uganda. It concludes that efforts to increase access to ARVs should go hand-in–hand with the efforts needed to ensure that every patient receives adequate adherence support. Failure to do this will jeopardize the future of treatment programmes.

In 2006, a project in Pakistan on the rights of HIV/AIDS patients was completed successfully. The project, run by the Pakistan National AIDS Consortium and Interact Worldwide, aimed to prevent HIV from becoming established among the most vulnerable groups in Pakistan and to reduce stigma and discrimination.

In 2006, KIT Biomedical Research started capacity building for HIV-related clinical research in Uganda and Rwanda.

Sexuality and reproductive health care

In many countries, expanding reproductive health services to include sexuality and sexual health continues to be a challenge. In 2006, KIT and the World Health Organization conducted a systematic review of cases where sexuality had been effectively integrated into sexual and reproductive health care and HIV/AIDS counselling, and the contribution this made to improving health outcomes. In 2007, KIT Development Policy & Practice will conduct studies in collaboration with partners in Brazil, Kenya, Uganda and India to assess the quality of sexuality counselling and the factors determining success. The purpose of the studies is to develop guidelines on how best to address sexuality in sexual and reproductive health care programmes.

Safe motherhood

Although maternal health care in low-income countries has received increasing attention in recent years, we are still a long way from achieving the Millennium Development Goal for maternal health. Large disparities in maternal health status continue to exist between developed and developing countries, and within countries themselves. In 2006, KIT assisted the Ministry of Foreign Affairs with a mapping exercise and an analysis of maternal health policies at global level. The resulting report, entitled *Mapping maternal health: A concise inventory and analysis of maternal health policies at a global level*, outlines the mandates and strategies of the UN and other organizations, the status of their plans and current funding levels.

Collaboration with Anton de Kom University Library in Paramaribo

The collaboration between KIT and the Anton de Kom University Library in Paramaribo focuses not only on enhancing the library's digital capacity, as described above. The two institutions also hope to contribute to the creation of a national database for Suriname, bringing together all the bibliographical information on Suriname held by Surinamese knowledge institutions and making it accessible in a central online catalogue. The possibility of connecting the KIT Library's collection to the database will also be investigated.



Learning strategy for patient health

Integrated Management of Adolescent and Adult Illness (IMAI) is a learning strategy for patient health developed by WHO. The strategy combines the acute and chronic care models, and supports both prevention strategies and antiretroviral therapy. A training programme has been developed for nurses, primary health workers and medical staff in low-resource settings, and a Clinical Learning Programme for doctors has recently been initiated, including the development of learning materials. KIT Development Policy & Practice coordinated the expert group writing the TB/HIV sections of the training materials.

Better access to health care

In many countries a visit to a doctor or hospital puts a heavy burden on the household budget. 2006 saw the start of a three-year project examining health care in Ghana, Tanzania and South Africa with the aim of finding new approaches to health insurance to improve equity in the health care system. This collaborative project involves research institutes from Africa and elsewhere in Europe.



1.4 Information management

KIT Information & Library Services focuses on building the capacity of partners in developing countries. It provides advice, training and technical assistance to libraries, documentation centres and institutions concerned with disseminating and exchanging information. It also helps partners to find IT solutions. The exchange of knowledge and experience with and between partners is central to this approach.

Virtual community

One way in which communication and knowledge exchange with partners in developing countries occurs is through a virtual community managed by KIT. On the basis of a three-year agreement with Reed Elsevier we can offer our partners in the South access to online databases with scientific information that would otherwise be available only under licence. In 2006, a study was launched to explore how virtual environments can support development processes.

Anton de Kom University library goes digital

KIT has worked closely with the library of Anton de Kom University in Paramaribo, Suriname, for over ten years now. Work focuses on building the library's capacity for digital services and information provision, with the support of an ICT consultant from KIT. He has trained library staff in the use of the library's software and advised them on digital library and information services. The development of the library's website has been a key element of this work.

Information services in Ghana


In 2006, ten projects were carried out in developing countries, most of them long-term. One good example is the Ghana Agricultural Information Network System (GAINS) project, which started in 2002 and was completed during 2006. GAINS is the hub of the library and information services in the Ghanaian agricultural sector. One outcome of the cooperation with KIT has been the development of a virtual library. KIT promotes organizational development by providing advice, training and coaching for local staff.

Another good example in Ghana is a joint project launched in 2006 with the Association of African Universities, using ICT to promote the development of the AAU Resource Centre. KIT has high expectations of this strategic collaboration, in which Reed Elsevier is also a partner.

IT in development projects

In 2006, KIT started a project called *Mainstreaming of ICT*. The aim of the project, also known as ICT for Development or ICT₄D, is to boost the role of ICT in development projects. A lot of expertise has already been built up in the field of information management, and this is being consolidated and more widely applied in *Mainstreaming of ICT*, to ensure that KIT projects in other fields also benefit.





Social Development and Gender Equity

In many countries women are not treated as full-fledged citizens and this is reflected in a lack of political participation, limited access to education, information and economic opportunities and a denial of their bodily integrity. Together with local partners, KIT Development Policy & Practice promotes equal rights for men and women, and women's empowerment.

Gender education and training

KIT has a long track record in gender education and training. In 2006, various tailor-made training courses were organized for staff of Dutch embassies, the Ministry of Foreign Affairs, the United Nations

and local interest groups. In addition, KIT initiated a worldwide debate on gender training and education. In an online discussion people from all over the world shared their experiences and views. KIT is now preparing for an international conference entitled *Revisiting gender training: the making and remaking of gender knowledge*, to be held in 2007.

Gender mainstreaming

Another strategy to promote equality between men and women is gender mainstreaming, which addresses inequality within organizations and also in their external activities. KIT took part in a worldwide evaluation of the gender policy implementation of the Commonwealth Secretariat together with the Centre for International Training and Education at the University of Wolverhampton in the UK.

KIT produced a publication that documents and analyzes the experiences of a joint Novib-KIT project that aimed at strengthening the capacity of local partners in Asia and the Middle East in promoting gender equality from an organizational change perspective. It was found that the organizations had to undergo radical change themselves before they could make a genuine contribution to gender equity in their societies. The Oxfam Novib-KIT publication is entitled *The Politics of the Possible*.

Promotion of gender-inclusive citizenship

KIT is working on the promotion of gender inclusive citizenship in different countries. In Niger, Burkina Faso, Mali and Senegal preparations are made to undertake a programme that will enhance the capacities of local civil society organizations to promote women's political participation, economic rights and access to justice. In Brazil a new programme was developed that will strengthen the economic, social and organizational capacities of local women's groups, youth and ex-slave afro-descendent communities in the Amazon and will contribute to the development of capabilities and agency of these groups to promote inclusive citizenship. The programme includes the development of innovative partnerships with the private sector.

In the wider field of social development, KIT is taking part in a new three-year programme funded by the EU to study health policy-making processes in Vietnam, India and China. Our partners are four European organizations specialized in international health and one academic institution from each of the participating Asian countries. The chosen focus for this research programme is maternal health. KIT is primarily responsible for guiding the investigation on the role and influence of civil society in policy-making in the countries concerned. Case studies will focus on abortion, skilled birth attendance, access of adolescents to sexual and reproductive health services, and domestic violence against women.

Worldwide debate on gender training and discussion

Having decided to take a critical look at gender training and education worldwide, KIT organized an online debate in which more than forty people from all four corners of the globe shared their experiences. The results of this exercise and the reflections of experts from all over the world will be published as part of the KIT-Oxfam Gender, Society & Development series. KIT is now preparing for a conference entitled Revisiting gender training: the making and remaking of gender knowledge, due to be held in 2007.

1.6 Sustainable economic development

KIT works to improve the livelihoods of vulnerable producers in developing countries. The primary focus is on encouraging pro-poor growth – an approach in which economic growth also benefits the poor – in rural areas while supporting social equity, environmental sustainability and sound economic development through research, policy development and training.

Sustainable poverty alleviation

A two-year KIT programme, supported by the Dutch Ministry of Foreign Affairs and inaugurated in 2006 focuses on engaging companies in sustainable poverty alleviation. The approach was tested in pilot business ventures between companies in Europe and small-scale producers in low-income countries. In 2006 pro-poor business ventures were launched for the production of biodiesel (Mali), ginger (Sierra Leone and Tanzania), lemongrass (Sri Lanka), sustainable tuna fishing (Ghana) and cocoa production (Dominican Republic). KIT Development Policy & Practice sees its role as supporting and monitoring these ventures.

Economic development and large-scale poverty

KwaZulu-Natal is the most densely populated and industrialized province of South Africa. It has a diverse economy, good infrastructure and a rich natural resource base. Yet 40% of the population is unemployed and 60% lives in poverty. In 2006, in the context of a programme commissioned by the EU to achieve more equitable economic growth, KIT and various partners set up a research facility where new approaches to pro-poor economic chain development can be monitored and tested.

Embassies help host countries

Dutch embassies can help solve development problems in their host countries. In 2006, to support the embassies in these efforts, the Dutch Ministry of Foreign Affairs launched the Support Programme for Institutional and Capacity Development (SPICAD) programme. Democratization, transparency, public sector reform and poverty analysis are just some of the areas that will be covered. KIT is managing this coaching programme jointly with Wageningen International.

Chain empowerment

Chain Empowerment: supporting African farmers to develop markets, published in 2006 by KIT, Faida Mali and the International Institute of Rural Reconstruction, is a popular publication. The book shows Africa's smallholder farmers how they can earn more from their crops and livestock by taking more control over the value chains in which they are a part. The book highlights basic strategies and case studies as examples of best practice. Since the book's publication, the organizations involved have set up a learning alliance for market access and value chain development.



For many years innovation was held up as an ideal way of promoting agricultural development. The focus has now shifted towards the involvement of private sector, civil society and farmers' organizations. In 2006 KIT Development Policy & Practice and a number of partners brought out two publications, one on research and innovation and the other on farmers' organizations: *Stakeholder-driven funding mechanisms for agricultural innovation: Case studies from Sub-Saharan Africa* (KIT Bulletin 373) and *Farmers' organizations and agricultural innovation: Case studies from Benin, Rwanda and Tanzania* (Bulletin 374). The findings of KIT's research in these areas were presented at a symposium in Kampala entitled *Innovation in Africa* and at a preparatory workshop for the World Bank's World Development Report.

Mango Task Force in Mali

In 2006, KIT and the *Institut d'économie rurale* (IER) celebrated 30 years of collaboration – perhaps the oldest development partnership in Dutch history. What began primarily as a research partnership on rural development in Mali has evolved over time, moving beyond food production and towards food processing, value adding and marketing. One striking example of innovative public-private partnership is the Mango Task Force set up in Mali in cooperation with Ahold's Sustainable Trade Development Programme. The aim is to develop the mango chain, ensuring a reliable supply and consistent quality, and expand exporting opportunities for Malinese farmers, allowing them to earn more than on local markets.

Medicinal plant for the treatment of malaria must become widely available

Malaria is responsible for large numbers of deaths in developing countries. It is difficult to fight the disease because the parasite that causes it becomes resistant to commonly-used anti-malaria drugs. An effective alternative is Artemisinin, extracted from the Artemisia plant, which comes originally from China and is known in English as Sweet or Chinese Wormwood. However, artemisinin is not yet produced and distributed on a large scale. The Dutch Ministry of Foreign Affairs asked KIT Development Policy & Practice to document the situation, and the results have been published in *The World of Artemisia in 44 Questions*. The publication received such a widespread response that KIT has set up an online community to promote the exchange of knowledge about Artemisia.

Labour law and human rights

KIT has developed instruments for analyzing the working conditions of foreign partners, local chains and suppliers, and how they comply with labour laws. In combination with analysis of local cultures and conditions, KIT can advise on the application of international ethical standards in specific local situations.

Microcredit and training in Kenya

Research has been conducted in Kenya to find the best way of helping small and medium-sized businesses to launch and grow. Microcredit alone proved insufficient. Besides credit, Business Solutions Centers now offer a comprehensive training programme which covers everything from bookkeeping to marketing, and from setting up a website to developing international trade. This combination of services aims to provide continuity and sustainability for small and medium-sized businesses.

International business consultancy

In 2006 KIT Intercultural Management & Communication set up an e-coaching programme on working abroad. Country and business experts advise managers on how to negotiate with partners and governments, how to manage local employees and on a code of conduct for suppliers. The department's International Business Consultancy services have been further developed and expanded. In addition to venture audits it now also offers stakeholder reviews, effectively an analysis of differences in conditions, cultures and interests between all local and international partners involved in an alliance. International Business Consultancy also offers advice on how to synthesize and integrate the differences. Our network of experienced managers extends throughout Asia, Eastern Europe and Africa.

Dutch businesses in China and India

KIT Intercultural Management & Communication has surveyed 30 Dutch managers and their families in China to obtain a picture of "best and worst business practice". The challenges facing the managers range from the independent attitude of Chinese experts to the introduction of quality standards and a code of conduct for suppliers.

In India, managers' experiences with outsourcing, setting up and taking over companies, and using local distributors have been studied. The department's advisory services now draw on insights from both studies.

Diversity


KIT Intercultural Management & Communication has a range of programmes on ethnomarketing and cultural diversity which businesses can use for innovation in the Netherlands and abroad. We can provide advice on policy and diversity based on our clients' experiences.

KIT studies and advises on ways of using diversity as a tool in organizations ranging from financial institutions to housing associations to improve sales and customer service, and for product development and marketing.

At home with diversity

KIT uses its knowledge and experience of intercultural communication in the Netherlands, too, helping organizations with their diversity policy. Such policies not only promote mutual understanding, they also represent an investment that can boost an organization's productivity, innovation and creativity. Companies and organizations looking to respond to the diversity in society can turn to KIT Intercultural Management & Communication for training and consultancy services. In 2006 the department ran several training courses for an insurance company, a health care institution





Every year, millions of people die because they have no access to health care, and their condition is diagnosed too late, if at all. Diagnostic resources are unavailable in many cases. Early identification is essential if therapies are to be effectively deployed, and to give us a deeper understanding of the epidemiology of different diseases. The crucial role of diagnostics in combating disease, and the high costs involved, mean that better policies and guidelines must be developed for their rational and cost-effective use. Cheap, simple methods are needed that meet the requirements of disease control programmes and patient care in developing countries.

International reference laboratory

In 2006 KIT Biomedical Research embarked on an EU-cofunded international project designed to develop molecular diagnostic tests for leishmaniasis and African trypanosomiasis (sleeping sickness). Recognized as a reference laboratory for leptospirosis by national and international organizations, including the World Health Organization (WHO), the Food and Agriculture Organization (FAO) and the World Organization for Animal Health (OIE), KIT Biomedical Research has done a great deal of work on the diagnosis and surveillance of this disease. The laboratory's quality assurance system was CCKLaccredited (ISO 15189) in 2006.

Diagnostics of infectious tropical diseases

KIT Biomedical Research has a leading international reputation in the diagnostics of infectious tropical diseases. The department successfully manages to translate its scientific knowledge into useful products, developing and improving diagnostic tests for malaria and tuberculosis, as well as for many orphan diseases and sexually transmitted diseases.

Tests with WHO and FIND

In 2006 KIT completed the development of several tests, including one for Brucella-specific antibodies. The development of lateral flow tests for identifying brucellosis in cattle has now begun. KIT has developed a Dri Dot that shows the presence of typhoid fever, in collaboration with Hasanuddin University in Indonesia and Omega Teknika in Ireland. A start has been made, in collaboration with the Prince Leopold Institute of Tropical Medicine in Antwerp, on a rapid test for cerebral sleeping sickness. KIT is working with World Health Organization (WHO) and Foundation for Innovative New Diagnostics (FIND) on this project. It signed a partnership agreement with FIND in 2006.

Innovative technology

2006 saw more collaboration on nanotechnology, as part of the drive towards more effective use of innovative technologies. KIT Biomedical Research is involved in the development of a simple noninvasive malaria test. The department is also participating in the Sensing and Diagnostics on a Chip consortium, which aims to develop ultra-sensitive biosensors for various diseases, particularly tuberculosis. Progress has been made on the development of the electronic nose into a simple breathalyser that can identify tuberculosis. Evaluations were launched in South Africa and Tanzania in 2006.



KIT offers short courses and workshops at its training centre in Amsterdam and organizes regional, tailor-made training all over the world. A number of examples of the varied and often unique training courses we provided in 2006 are described below.

Training

Intercultural training

The demand for training in intercultural management and communication is rising. Many training courses were given on China, India, and the newly independent states in Eastern Europe. The number of group training courses rose, creating a wide variation in themes. KIT is delivering more and more customized training courses. Many of the India training courses, for example, were in client services and chain management in outsourcing. Sixty young knowledge workers from India also received training in Western management styles and methods. The demand for product innovation geared to new international client groups is on the increase, as is the demand for consultancy on international contract and project management.

International leadership development

The International Leadership Development programme has been expanded. Besides teambuilding and negotiations, it now also includes detailed modules on innovation, entrepreneurship, strategic management, business ethics and corporate social responsibility. HRM departments at major companies are interested in the development of international competencies and recruitment of foreign managers and knowledge workers. The programmes are flexible and focused on global applicability, though they can also be tailored to specific countries or regions.

E-coaching and blended learning

KIT Intercultural Management & Communication has launched an individual e-coaching programme. Blended learning, based on the Virtual Action Learning method is available for groups. This programme integrates working and learning, and includes live training programmes, implementation in the workplace and virtual exchange of knowledge, experience and ideas. The programmes are intended mainly for organizations in the Netherlands, but are also available to international companies wishing to use virtual communication in work and learning processes.

Geographical information systems

KIT Biomedical Research and ITC in Enschede have developed a course bringing together expertise in geographical information systems (GIS) and their application to public health. Students gain knowledge and skills on how GIS can be used for TB control, focusing on the epidemiological assessment of the disease burden and improvements to programmatic planning and management.

KIT gave an international course entitled Laboratory Methods for the Diagnosis of Leptospirosis in Amsterdam and in Havana, Cuba.

Training for Dutch military doctors

In 2006 KIT Development Policy & Practice provided a new three-week training course for preparing Outbreak Response Teams. The course was specially designed for the Ministry of Defence. The teams will be deployed when an imminent outbreak of disease is suspected among armed forces personnel stationed abroad. The 20th edition of GOLAMA, a course to prepare military doctors for out-of-area operations, was also held in 2006, marking ten years of cooperation between KIT, Amsterdam Medical Centre and the Dutch Ministry of Defence.

Training in the Egyptian pharmaceutical sector

Egypt's pharmaceutical sector is being reformed as part of wider health sector reforms. KIT and Health Care International in Cairo ran a training programme in 2006 focusing on planning and management in the pharmaceutical sector. In total, about 500 people took part, including pharmacists, inspectors, managers and researchers from major organizations.

Rural development and institutional change

Representatives of NGOs from across French-speaking Africa attended the third annual *Décentralisation rurale et gouvernance locale* course in Wageningen. The course is co-organized by KIT Development Policy & Practice and Wageningen International. Participants gained a greater understanding of their organization's role in good local governance for rural development, and learned to apply current methodologies and tools for institutional change.

Programme on gender, citizenship and governance

Participants from Sudan, Algeria, Yemen and Tunisia gathered in Beirut for the second annual Regional Training Course on Gender, Citizenship and Governance. Jointly organized by KIT and the Collective for Research and Training on Development Action in Lebanon, the course aims to familiarize participants with strategies to ensure that gender equity and equality are prioritized on the governance agenda. The course contents were tailored to the specific gender context of the Middle East and North Africa.

Learning platform in Mali on decentralization and governance


In 2006 KIT Development Policy & Practice facilitated a learning platform on decentralization and governance for the eleven civil society partners of Dutch development organization ICCO. Four workshops were held in Mali, one in the Netherlands and coaching was provided for partner organizations. The first two workshops were held in 2006, focusing on multi-stakeholder processes and strengthening accountability mechanisms.

Land rights and reconciliation in Burundi

Burundi has experienced several violent episodes over the past few decades, forcing people to abandon their land and move to other parts of Burundi or to neighbouring countries. With the 2005 elections marking the start of a new period of stability, the Netherlands offered the newly-elected president support for micro-credit and the securing of land rights in particular. In 2006, KIT ran a workshop in Burundi with the *Commission National des terres et autres biens*. The aim was for participants to discuss their experiences of dealing with land conflicts and explore strategies for promoting reconciliation. The workshop formed part of a larger project that KIT Development Policy & Practice is undertaking for the Dutch Ministry of Foreign Affairs to design a programme of work towards securing land rights in Burundi.

Chain development for good trade flows

KIT Development Policy & Practice ran three workshops during a meeting in Montpellier, France, of the International Centre for Development Oriented Research in Agriculture (ICRA), which has branches in Montpellier and Wageningen. The workshops, which focused on the pro-poor perspective, looked at chain development for the development of good trade flows between farmer and consumer, to ensure that the producer ultimately profits from his yield.



Academic courses and programmes

Membership in tropEd, a network of institutions for higher education in international health, has helped raise the standard of KIT's master's programmes and short courses, and profile it as a leading institution for health training.













KIT's academic courses are those that have external accreditation, including the International Course in Health Development/Master of Public Health (ICMD/MPH), the Master in International Health (MIH) and the short courses and modules affiliated with these Master's programmes.

Demand for KIT Master's programmes has continued to grow since they were accredited by the Netherlands-Flemish Accreditation Organization (NVAO) in 2005. The Master in International Health programme now benefits from an EU grant in the form of Erasmus Mundus scholarships offering financial support to students from developing countries who apply to study at KIT.

Underpinning these achievements is KIT's participation in tropEd, a network of institutions for higher education in international health. Participation has strengthened KIT's institutional ties with 29 other European training institutions, and, with the addition of three Southern institutions to the network in 2006, it will strengthen KIT's global ties as well. Participation in tropEd ultimately enhanced the quality of KIT's masters courses and short courses and increased KIT's visibility as a leading institute for health training.

Public and International Health

2006 was an exceptional year for the International Course in Health Development, with 34 participants from 23 countries enrolling in 2006-2007. This is the highest number of enrolments in the 42-year history of the course. Meanwhile, 22 students graduated from the 2005-2006 session, earning the degree of Master of Public Health.


The Master in International Health (MIH) degree was awarded for the first time by KIT and the Vrije Universiteit Amsterdam in 2006. Six students graduated after following courses at KIT and other European institutions. A further nine students completed the core course of the MIH and are now working towards the MIH degree.

Netherlands Course in Tropical Medicine and Hygiene

In 2006 30 students graduated from the Netherlands Course in Tropical Medicine and Hygiene (NTC), a programme that prepares Dutch doctors for work in developing countries. The NTC is also the core course for the Master in International Health, and as such is an entry qualification for this programme. In December 2006, half of the NTC graduates were continuing their studies in order to obtain an MIH degree. As the Master in International Health becomes better known in non-Western countries, the diversity of students on the NTC is likely to increase further, adding to the value of the course, which emphasizes on discussion and the sharing of experiences in its approach to learning.

Biomedical PhD students and interns

In 2006 KIT supervised PhD students from a number of countries. Many undergraduates studying for a Bachelor's or Master's were also given the opportunity of working as an intern in our laboratory or with one of our foreign partners.



The Internet can bridge great distances and is the portal to the global village. There is a growing awareness that it is an inexhaustible supply of knowledge, which is becoming more freely available for development and education. With relatively little investment, developing countries are now able to catch up in terms of their access to knowledge. KIT Information & Library Services is keen to play a role in this process, and expanded its virtual library in 2006. Many digital documents were added to online case files and the number of online users saw a spectacular 70% rise, to reach

The Internet and better governance

Royal Tropical Institute Information services

In March 2006 KIT took part in the International Forum of ICT Strategies and Investment in Marrakech, Morocco. Another participating organization, the African Development Bank, indicated that it regards ICT as a priority in education, health care, agriculture and infrastructure. The fact that the Internet contributes to more transparent political processes, better governance and democratization, as well as promoting better understanding of multicultural societies, was underlined at the conference.

Information and development

KIT uses information to address development issues. More and more information products appear exclusively or additionally on the KIT website or the sites of external clients. In 2006, a number of Internet dossiers were published, online case files tying in with current development issues. The case files contain background information and a compilation of sources on the Internet and in the KIT library.

Thematic portals

The first information portals – virtual thematic libraries that provide access to online sources – were launched in 2006. In addition to the sources themselves, the portals include bibliographical information and keywords. The themes tie in with KIT's focal points. Two portals were online by the end of the year: Culture for Development and Rural Innovation Systems. This service will be gradually expanded.

More and more online library resources

With some 20,000 journal titles, including 4000 current subscriptions, the KIT Library is one of the world's largest libraries specializing in development cooperation. A further 7000 titles were added to the library in 2006, taking its total to over 300,000 volumes. The licence with Reed Elsevier has been extended, and now includes the Scopus search engine, which provides access to 15,000 journals and 250 million web pages. The KIT Library has a licence for the ScienceDirect online database with over 1700 full text journals. Physical visits to the library fell in 2006, while the number of online visits grew sharply, as did use of the SwetsWise and ScienceDirect databases.

Selective dissemination of information

The Selective Dissemination of Information (SDI) service for partners in developing countries was further automated in 2006, and is now able to serve more organizations. SDI agreements have been concluded with a large number of organizations in Africa, Asia and Latin America.

2006 was an exceptionally good year for the Tropenmuseum. No fewer than nine exhibitions opened in Amsterdam, and seven exhibitions were staged in other museums at home and abroad. A total of 167,125 visitors passed through the museum's doors - 7,239 more than in 2005, also a highly successful year. The museum had expected a fall in visitor numbers, as Tropenmuseum Junior was closed for six months for the installation of the new exhibition. The Bombay Star – a 90-minute tour of Bombay exhibition was opened after HRH Princess Máxima had enjoyed a sneak preview. Bombay Star, extra activities in the summer, our new Africa exhibition and the Beauty and the Bead exhibition generated a great deal of media attention and drew large numbers of visitors in the second half of 2006. The Tropenmuseum was also active on the international stage. An exhibition on the Bidesia project (see page 14) opened in the Indian city of Allahabad in September, and 45 art objects were transferred to the Surinaams Museum. Tropenmuseum exhibitions travelled to Switzerland, South Africa and Indonesia.

Exhibitions

Dealing with the Gods – Rituals in Hinduism

Royal Tropical Institute Tropenmuseur

Until mid-September the Light Hall was home to Dealing with the Gods, an exhibition about the rituals, gods, customs, smells and colours of Hinduism. Visitors could follow a path to wealth, wisdom or love through the world of Hinduism, "dealing" with the gods themselves. One of the highlights of the exhibition was a thousand-year-old statue of the sun god Surya from the museum's own collection. It was purchased with the support of the Mondriaan Foundation. Unique objects were also on loan from the Pitt Rivers Museum in Oxford, the Victoria and Albert Museum in London and from private collectors. The exhibition included a great deal of audiovisual material that transported visitors to the banks of the holy river Ganges.

Batak in the Picture

The culture of the Batak from Northern Sumatra was showcased in the Batak in the Picture exhibition in the Park Hall and Gallery. The Batak culture is well known for its fabulous weaving techniques that date back centuries. Contact with the colonial powers from the 18th century onwards brought cultural change to the Batak. The textiles exhibited in the Park Hall illustrated the developments in both weaving techniques and the social context. In the Gallery, an exhibition of photographs by Tassilo Adam focused on Batak culture. Adam, an important collector for the Colonial Museum, took hundreds of photos showing Batak life around 1900.

Bombay Star

At the end of September the Tropenmuseum Junior opened its Bombay Star exhibition about this huge Indian city with its millions of inhabitants. Bombay Tours enable young visitors to meet the people who live there, from slum dwellers to Bollywood stars. Under the guidance of mostly Indian staff members, the children take part in activities to learn about life in Bombay. Stories, objects, dance, music, smells and tastes bring the city to life. Bombay Star focuses on the contrast between rich and poor, child labour, family values and Bollywood, the popular Indian film industry. A video clip featuring Asha Bhosle, one of India's most famous singers, was shot specially for the exhibition in Bombay. Children on the Bombay Tour can dance in front of the camera and appear in the clip in real time, allowing them to become real 'Bombay stars' for a while. The exhibition has been staged in partnership with Plan Nederland and the Liliane Fund.

Sub-Saharan Africa

A weekend of African festivities marked the opening of the new permanent *Sub-Saharan Africa* exhibition in November. The exhibition presents a dynamic picture of the diversity of African culture and the many changes taking place on this continent. A 19th-century Senufo ancestral statue from Ivory Coast and an early 20th-century Vili Janus mask stand alongside contemporary street art, fashion and design. Part of the *Latin America* exhibition has also been redesigned by artist Marcel Pinas from Suriname. He was commissioned to design an installation in which the Tropenmuseum's collection could be incorporated in a contemporary display showing the connections between Africa and Latin America.

Inside Iran

From 22 September, a retrospective of Iranian artist Khosrow Hassanzadeh could be seen in the Park Hall. Though his work is known throughout the world, this was his first retrospective, as well as his debut in the Netherlands. Hassanzadeh lives and works in Iran, depicting in his paintings the political and social developments that are inextricably bound up with his personal experiences and vision. The exhibition included a series of paintings about his time as a soldier in the Iran-Iraq war, and the museum purchased his 2004 series *Terrorist* with the help of the Mondriaan Foundation.

Also showing

The installation *Layla & Majnun* opened in the Kartini Wing on 11 May. Farshid Mesghali and Ahmad Khalili from Iran designed an art installation and a story cloth depicting the famous Iranian love story Layla and Majnun. This theme also featured in the Tropentheater's programme.

From 9 June to 10 September a retrospective of Brazilian photographer Rogério Reis was staged in the Gallery. *Skull Smashers from the South Seas* opened in the Gallery on 6 October. Eleven of the clubs on display were found to originate from the 18th-century French expedition led by Antoine Bruni D'Entrecasteaux. These are the oldest clubs in any museum collection, after those brought back by James Cook.

Exhibitions on tour

The Tropenmuseum exhibition *Urban Islam* opened at the Museum für Völkerkunde in Basle in January. *Yogya Silver*, a 2005 exhibition, was on show at the Erasmus House in Jakarta from February, and our *South African Family Stories* exhibition could be seen at the National Cultural History Museum in Pretoria, South Africa, throughout 2006.

In September old photographs and film material from the Tropenmuseum collection were shown at the ninth International Photography Gathering in Aleppo, Syria. The *Kahe Gaile Bides – Bhojpuri Culture and the Diaspora* exhibition, which came about with the support and advice of the Tropenmuseum, opened in Allahabad (India) on 13 September (see page 14).

On 29 June the Sticusa collection was transferred to the Surinaams Museum, and several pieces from the collection were put on display in a special exhibition.

Acquisitions

The selection criteria for acquisitions have been tightened up. There were 400 acquisitions in 2006, including modern art, popular art and design objects. A number of unique pieces were purchased for the revamped *Sub-Saharan Africa* exhibition, including *Peace Bird* (2003) by C.A. Mabunda from Mozambique. This statue is made of rifle, machine gun and hand gun parts. Other examples include a 2005 sculpture by Ethiopian artist M.B. Selassie entitled *La Magicienne* and the *Terrorist* series of four

silkscreens by Khosrow Hassanzadeh. The photo collection was extended, with the addition of an important gift of albums and photographs from the Indisch Wetenschappelijk Instituut. An acquisition trip to India and Bhutan resulted in several purchases, including a Bhutanese domestic altar for the new permanent India exhibition, which is due to open in mid-2007. Like *Terrorist* and *La Magicienne*, the altar was purchased with the support of the Mondriaan Foundation. Surinamese artist Marcel Pinas was commissioned to produce an installation linking the Latin America and the Caribbean and Africa exhibitions, using objects from the museum's collection. Iranian artists Farshid Mesghali and Ahmad Khalili designed an art installation and a story cloth specially for the Tropenmuseum. They can both be seen in the Kartini Wing, providing a foretaste of the Music, Dance, Theatre and Non-material Heritage department, which will open in autumn 2007. Acquisitions and productions were sponsored by the Mondriaan Foundation.

Round the world with the Tropenmuseum

A promotional campaign entitled *Join the voyage around the world!*, launched to counter the fall in visitor numbers during the summer, proved to be a success. More young visitors came to the museum, and August was in fact a record month. New products included a musical trip around the world (*Daar zit muziek in!*) and a holiday activity book for children aged 8-12 and their parents. Young visitors also got the opportunity to explore our Eastward Bound! exhibition with a special guide for children aged 8-12.

Tropenmuseum Junior

Both the exhibition *Paradijs & Co.* and the exchange project *Kids-at-Iran.nl* closed at the end of March. The latter was designed to allow Dutch and Iranian children to learn about each others' daily lives and culture. To mark the end of the project, 16 children from Amsterdam primary schools visited the Iranian capital Tehran to meet the 34 Iranian children they had got to know over the past two years in person.

Preparations for the new *Bombay Star* exhibition involved close collaboration with partners in Bombay, including a producer, film maker and composer. Focus groups made up of experts and representatives of the education sector provided input in the Netherlands.

Teaching packs have been developed for schools, including a copy of the *Bombay Star* book, published by KIT Publishers (165,000 copies), for each pupil. Schools have already shown great interest in this new exhibition, and the Bombay Tours for schools were fully booked for the entire school year even before they had started.

Highlights of 2006 at the Tropentheater included in-house productions like youth production *Kerto en de Zeekoningin* ('Kerto and the Queen of the Sea') and performances based on the *Arabic love story Layla and Majnun*. The theatre attempted to broaden the range of its programming in 2006, with accessible and original productions, as well as exclusive series and new themes. The theatre's programming is now more coherent and based on more solid foundations, and many new series were presented in 2006. Services to the public have been improved, with prebooked seats now available. Many people now reserve online through the new website.

The year started badly, however, as visa problems led to the cancellation of concerts by Sherap Dorjee from Tibet and Qawwal Bahauddinn from Pakistan. Technical problems for Mexican musical theatre company Teatro del Farfullero meant the try-out and one of the four planned shows had to be cancelled.

The theatre offers a core programme in collaboration with theatres in both the Netherlands and Belgium, and its own productions that profile the Tropentheater as a venue for non-Western performing arts. In-house productions such as the musical theatre production *Kaittakkuttu Sangam* from southern India, which showed in January, are sponsored by external financers. The company's tour, and that of other Indian artistes including Kala Ramnath, was organized by the Tropentheater.

6.1 Performances

Forbidden love

Tunisian singer Ghalia Benalli and Sevari Nazarkhan from Uzbekistan opened the 2006-2007 season with *De onmogelijke liefde bezongen* ('Songs of Forbidden Love'), the first part of the *Layla & Majnun, een geschiedenis over onmogelijke liefde* ('Layla & Majnun, a story of forbidden love') trilogy. The second part, *Layla & Majnun, een compositie over het nachtelijke* ('Layla & Majnun, a composition of the night') by composer and librettist Rokus de Groot was performed by the Nieuw Ensemble and the Nederlands Vocaal Laboratorium. This production will return in 2007-2008.

Amsterdam-Feztival

Another highlight was the Amsterdam-Feztival opened by Mayor of Amsterdam Job Cohen in October, linking the Tropentheater's activities with the Ramadan Festival. The concerts by Mohammed Briouel & L'Orchestre Arabo Andalous de Fè were a particular success.

Amsterdam-Feztival

In early October, the Tropentheater was one of the venues for the Amsterdam-Feztival. Visitors could experience the atmosphere and rich culture of the Moroccan city of Fez. Three special concerts, documentaries and a poster exhibition illustrated the musical diversity and architectural splendour to be found in and around Fez. The aim of the Amsterdam-Feztival was to create a platform for better dialogue between Islam and Christianity, and between Moroccan and Dutch people.

A world of new music

Our core programme included highlights such as a virtuoso performance by Iranian percussionist Majid Khaladj, a concert by Aynur & Mikail Aslan as part of the Kurdish film festival, master guitarist Manolo Franco and contemporary tango by Orquesta Típica Fernández Fierro from Argentina. Iranian kemanche player Kayhan Kalhor gave a surprising performance with Turkish baglama player Erdal Erzincan. In November Bi Kidude – at 93 the grand old lady of East African music – performed narrative songs from her illustrious career. The debut of the Romanian Godfathers of Balkan Beats the *Mahala Raï Banda* proved to be a real spectacle, and was followed by a party in true Roma style.

As people travel more and more, new musical forms emerge. Never has the dividing line between Argentinean tango and Western chamber music been so thin as during the moving performance by the La Comorra ensemble from Buenos Aires. Never were Son Cubano and Jewish Klezmer so intertwined as in the performance by Quinteto Rodriguez. Or, as newspaper *Het Parool* put it: 'The best Latin concert in years!'

Our programming transcends festivals and hypes. Audiences can enjoy Chinese music outside a festival setting, too, as evidenced by the concert and the meeting of three generations of musicians in the Xu Fenxia project.

Intimate dance performances

Intimate contemporary and traditional dance performances are a new feature of our programme. Bijayini Satpathy from India surprised her audience with her dance and her playful interpretations. German-Argentinean tango dancers Nicole Nau & Luis Pereyra gave a stunning performance and India Martinéz shared her fascinating interpretation of flamenco. Turkish choreographer and dancer Ziya Azazi gave a solo performance inspired by Sufi rituals and dervishes, in a co-production with ColourDance Festival.

Festivals


The Tropentheater presented a Kurdish film festival in collaboration with arthouse cinema Haags Filmhuis. For years, now, the first week of June has been reserved for *Beeld voor Beeld* ('Frame by Frame'), a festival for visual anthropology. As part of the Amsterdam Roots Festival, we staged concerts by Indian percussionist Trilok Gurtu, the Frikyewa Family from Mali and Algerian singer-songwriter Souad Massi. We also co-produced the Amsterdam-Dersim Festival which was devoted to the cultures of the Dersim region and the Zaza culture.

Series and packages

To attract new audiences, and as an innovative way of interesting the public in unfamiliar styles, the Tropentheater offers special series and packages. We participate in a number of festivals for both artistic and marketing purposes. Together with the Tropenmuseum, we put together an India package based on the Hinduism exhibition *Dealing with the Gods*. The package consisted of an introduction, an Indian lunch, a visit to the exhibition and an Indian theatre performance.

The *Film & Food* series remains very popular. In 2006 we presented *Music & Food* for the first time – a chance to experience both exotic music and exotic food, and it too has proved popular. The new series *Muziek in beeld* ('Music in the frame'), a documentary screening and an interview with one of the documentary makers conducted by journalist Stan Rijven, is another interesting addition.





2006 was a difficult year for KIT Publishers. Disappointing 2005 results meant that the year under review was dominated almost entirely by a reorganization, as staff numbers were reduced from 18 to 5. Hotei Publishing, which specialises in books on Japanese art and culture, became part of Brill Academic Publishing on 1 May. Children's magazine samsam is now published by the National Committee for International Cooperation and Sustainable Development (NCDO).


A great deal of work went into guaranteeing continuity. Almost all authors remained with KIT Publishers and suppliers also remained loyal. Over 30 new publications appeared, some of which were a great success. The catalogue for *Bombay Star* was published (165,000 copies) in collaboration with Tropenmuseum Junior and Plan Nederland. All the planned volumes of the Country Series were published. The book *Sinterklaas Overseas*, which is now available in four languages, was published in collaboration with Radio Netherlands Worldwide. The book received a lot of media attention, as did the popular series *Van onze correspondent* ('From Our Correspondent').



Sinterklaas overseas: the adventures of a globetrotting saint

The celebration of the birth of Saint Nicholas - Sinterklaas to the Dutch - in early December is more popular than ever in the Netherlands. Dutch people overseas also try to capture that feeling of home once a year. Sinterklaas Overseas paints an unexpected picture of how they celebrate this typically Dutch tradition, showing the saint arriving by boat on the Mekong, Nile or Yangtze, and continuing his journey overland by horse, pick-up truck, rickshaw, camel or elephant. The book includes more than 80 photos taken between 1907 and 2005 in a colourful procession of images showing how Sinterklaas pays his annual visit to 35 countries around the world. In early October, the Tropentheater was one of the venues for the Amsterdam-Feztival. Visitors could experience the atmosphere and rich culture of the Moroccan city of Fez. Three special concerts, documentaries and a poster exhibition illustrated the musical diversity and architectural splendour to be found in and around Fez. Introduction

General

The Financial Statements 2006 relate to all activities of the Vereniging Koninklijk Instituut voor de Tropen/Royal Tropical Institute Association (KIT), Holding KIT BV, KIT Publishers BV, Stichting Internationaal Centrum (SIC) including the NH Tropenhotel, Stichting Hubrecht-Janssen Fonds, Stichting Eijkman Medaille, Stichting Gresshoff's Rumphius and the Stichting Collectiefonds Tropenmuseum.

Activities are grouped by theme in the annual report. The financial report examines each department individually. The results of the individual departments are shown in the table below.

Turnover

KIT's involvement in the implementation of the Sustainable Development Agreements between the Netherlands and Costa Rica, Bhutan and Benin came to an end in December 2005. This produced a keenly felt fall in turnover of some € 2.5 million. The effect on the result was negligible, however. The fall was only partially compensated for in 2006 by a rise in turnover from other activities. The graph below shows trends in turnover from 2002 to 2006 relative to the result achieved in the same year. Though turnover is falling at consolidated level, shortfalls are also decreasing.


The Institute's turnover consists of market income, subsidies and output financing from the Ministry of Foreign Affairs. Output financing comprises funded services based on an annual product plan and product report.

The budget assumed a rise in turnover. While output financing rose from 2005 to 2006 by the annual half price inflation adjustment, market income – particularly from research and consultancy activities – saw a decline. To bolster income, a series of vacancies had to be filled. However, it is growing increasingly difficult to find suitable candidates. The fees that the Institute charges to cover its costs have also come under increasing pressure. As one of the actions to improve market income, KIT established 'Holding KIT BV' in 2006, to which KIT Publishers and the NH Tropenhotel


have now been transferred. KIT intends to participate in a number of 'Business Against Poverty' ventures in developing countries via this holding company. The first business plans have already been discussed.


Cultural activities had a good year in 2006, with rising visitor numbers and income. A great deal of preparatory work was done on the planned new development. After decisions have been taken on amendments to the zoning plan in 2007, the decision– making on the next steps in preparation for the new building can be finalised.

Balance shee

The graph below gives some indications of the balance sheet position from 2002 to 2006. It is clear that the association's cash and cash equivalents and operating capital are still adequate, after two consecutive years of absorbing losses. A justified decrease in investments in fixed assets such as 'buildings' and 'machinery & equipment' has helped keep the operating capital at an adequate level.

Participating interests

The annual accounts of Holding KIT BV, the International Centre Foundation (SIC, NH Tropenhotel), a number of small funds and KIT Publishers BV have been consolidated in this Annual Report.

The NH Tropenhotel did good business once again, with increased turnover compared to 2005. KIT Publishers BV, which suffered severe losses in excess of € 1.3 million in 2005, underwent a radical reorganization in 2006 and managed to close the books with a small loss of € 37 thousand. In line with the search for 'do well, do good activities', Holding KIT BV signed a contract with the Dutch government related to an investment in a biodiesel venture in Mali. Pending the outcome of the first phase of this project, investments will start in 2007.

Prospects

After two successive years that closed with a negative result in excess of forecast, KIT is now identifying measures it needs to take to perform on budget, and at least in such a way as to cover its costs. These measures will focus both on increasing the organization's income – including a greater focus on 'for profit' projects and activities without losing sight of KIT's aims – and on streamlining the administration. Ways of reducing overheads will also be explored. 'Furthermore, KIT is planning to adopt a more risk focused approach in 2007, towards which the first steps have been taken in 2006'. KIT's cultural activities will be focused on continuing the rise in visitor numbers and income. The planned new development may help in this respect.

Consolidation

The Consolidated Annual Accounts include the financial results of the Royal Tropical Institute Association as well as the results of the KIT Experts Foundation, the Stichting Internationaal Centrum, KIT Publishers BV, Holding KIT BV and all other foundations mentioned above, which form a single economic entity with KIT.

Foreign currencies

Assets and liabilities in foreign currency are converted at the exchange rates prevailing at the balance sheet date. The conversion differences are reflected in the Income and Expenditure Account. All transactions in foreign currencies are recorded at exchange rates prevailing on the transaction date.

Tangible fixed assets

Tangible fixed assets are valued at cost minus straightline depreciation based on the estimated economic lifespan, or at a lower market value. The depreciation of the different components is calculated as follows: Buildings (and renovations): from 3 to 50 years.

Hardware: 3 years

Financial fixed assets

Participating interests are valued at net asset value. Securities (investments by the Funds) are valued at market value at the end of the financial year.

Stocks

Stocks are valued at the lower of costs and net realizable value, less any provisions considered necessary.

Accounts receivable

Debtors and other accounts receivable are carried at face value less any provisions considered necessary.

Cash and cash equivalents

Cash and cash equivalents are carried at face value.
Unless otherwise stated, they are freely available.

General reserve

This reserve acts as a capital buffer. The operating result of the Income and Expenditure Account is credited or charged to this reserve.

Pension contributions

The KIT pension plan qualifies as a multi-employer defined benefit plan. It is therefore treated as a defined contribution plan. The pension scheme is insured by ABP. The agreement is that KIT has no obligations for deficits other than higher future insurance payments. According to ABP's information the fund has a covering rate in respect of its obligations of 130%.

Appropriated funds

These assets are funds transferred to the Association by third parties on condition that these funds, having a separate identity and purpose, will be used as stipulated by the third parties concerned.

Provisions

Provisions are carried at face value.

Other assets and liabilities

All other liabilities are carried at face value.

Principles for the Determination of Results

Income and Expenditure are allocated to the period under review during which products and services were supplied or costs and other expenses incurred. Losses are recognized as soon as they can be foreseen.

The balance shown on the Income and Expenditure Account is defined as the difference between revenues and expenses in the year under review, taking into account the above-mentioned accounting policies.
