International Conference 15 November (p.m.) - 16 November

Cross-border education is a response, at various levels, to increasing and unmet demand for education, a wish to effectively use expertise, capacity and new technologies to expand the educational offer beyond national borders, at times a means to diversify financial resources. Who are the major actors in this growing trend of international education? How is this phenomenon evolving around the world? How does this fit within the sending institution's strategy and what impact may this have in the host country? These are among the questions that universities and higher education institutions will come to debate. Various initiatives to report on the development, to counter undue commercialisation, to ensure that quality and relevance of what is offered across borders is maintained and to establish some international rules of the game have been taking place.

Participants at this International Conference, after hearing the results of the First Global Meeting of Associations, will reflect on the various models of cross-border education, on how these may or may not fit into the internationalisation strategies at their institutions and will work together to develop possible action plans to adopt at institutional level.
